basis to every business in Little Island and will be sent to Chambers of Commerce throughout Ireland and to the CEO's of the Top 1000 Irish companies as well as to all Irish Ambassadors in 66 countries across the world and IDA and Enterprise Ireland offices across the globe.

- To embark on a public relations strategy for Little Island that will result in greater awareness of the location as a premier business location for local, national and international businesses.
- To elect a Mayor of Little Island on an annual basis who will be a member of the business community and who will promote Little Island locally, nationally and internationally.
- To develop a Little Island Business Club that will meet weekly in the Radisson Blu Hotel to bring business to the businesses of Little Island and to keep business in Little Island.
- To develop a **Little Island Property Office** where a dedicated auctioneer will market available property in Little Island and encourage new businesses to locate there.
- To launch the annual **Little Island Business Awards** as a means of promoting the excellence in business that exists in Little Island and to encourage more companies to locate in Little Island.
- To encourage more food companies to base themselves in Little Island and market the area as **Cork's Food Island**.
- To develop Little Island research to show the value of the existing business there.
- To launch a Little Island loyalty programme to grow business for all based in Little Island and to encourage more people to visit and do business in Little Island.
- To engage with all bodies who can assist Little Island from an image, security and public relations perspective.

LITTLE ISLAND - AN OVERVIEW

Little Island is a residential, commercial and leisure area to the east of Cork city. To the east and south is Cork Harbour and across a channel, to the west, is Fota Island. Glounthaune is also an integral part of the Little Island area.

There are over 1,000 businesses in the greater Little Island area comprising of offices, professional services, industrial and commercial businesses. Many of Cork's pharmaceutical companies are based here. Since the 1990's, development has grown rapidly, with developments such as East Gate which consists of retail and commercial developments. The main drainage sewage treatment plant for Cork city was opened here in 2004. Cork Golf Club also has its home on the island. The Radisson Blu Hotel & Spa, a conference and banqueting hotel, is located at East Gate and there is a number of prestigious motor dealerships including Mercedes-Benz and BMW who have developed new facilities at East Gate. The N25 Cork-Rosslare road is built on the filled-in channel. The Cork-Cobh railway line skirts the island to the

north and west and includes Little Island railway station, which opened in 1859. The railway station has direct rail services to Cork, Cobh, Mallow, and Midleton.

RESEARCH ON LITTLE ISLAND BUSINESSES

Since 2005 Little Island has become the fastest growing and most progressive commercial district of Cork. The scale and quality of development is impressive. The O'Flynn Construction East Gate development has set a new benchmark for quality and location and with its new additions of a retail village, a motor mall and a retail park and the locating of the Radisson Blu Hotel in the complex, Little Island has it all. Bank of Ireland is the main banking providers in the retail village.

The Euro Business Park and other developments within Little Island have all benefited from this infrastructure. Other parks in Little Island have seen substantial development and refurbishment in the last five years. The arrival of Eli Lilly and the move by many city based offices to East Gate heralded a new future for the entire Little Island area.
